

Order Approving a Joint Election  
Between the County of Wharton and  
Independent School Districts of Louise and Boling  
On November 2, 2010

On this the 26<sup>th</sup> day of July 2010, at a regular meeting of the Commissioners' Court of Wharton County, Texas, acting as the governing body of said county, and upon the motion of Commissioner Miller, seconded by Commissioner Krinda, it is duly carried as follows:

Whereas, § 271.002 of the Texas Election Code permits the commissioners court of a county in which the election ordered by the governor is to be held and the governing bodies of the other political subdivisions may enter into an agreement to hold elections jointly in the election precincts that can be served by common polling places.

NOW THEREFORE, BE IT RESOLVED THAT the Commissioner's Court of Wharton County, Texas, hereby ORDERS as follows: A joint election be held between the County of Wharton and the Independent School Districts of Louise and Boling.







Said order is hereby adopted by the Commissioner's Court of Wharton County, Texas as the true and lawful order of said court.


