OPTION NO. 1 - PAYING TICKET:

Determine your fine by the schedule on the front of this letter. Send (1) a copy of the ticket, (2) this completed REPLY FORM, and (3) payment by CASHIER'S CHECK OR MONEY ORDER ONLY payable to Court circled on the front of this letter postmarked by the appearance date noted on your ticket.

OPTION NO. 2 - REQUESTING DRIVING SAFETY COURSE:

To be eligible you must:

- Have a Valid Texas Driver's License, and
- Not have a COMMERCIAL DRIVER'S LICENSE; and
- Not have taken the course within the last 12 months for dismissal of a ticket; and
- Not have been cited for 95 mph or more, or 25 mph or more over the posted speed limit.

• Send the following items, POSTMARKED BY THE APPEARANCE DATE NOTED ON YOUR TICKET:

- (1) This completed REPLY FORM, (2) proof of Liability Insurance; (3) copy of the ticket;
- (4) \$144.00 Court fee by CASHIER'S CHECK OR MONEY ORDER ONLY to Judge circled on front of the letter, (5) a self-addressed stamped envelope and (6) copy of your driver's license

You must enter a plea of NOLO CONTENDERE OR GUILTY, and complete the affidavit below. CHECK ONE:
