Martin Asphalt Co.: Demurrage charge \$95 /hour after 2 free hours

Cleveland Asphalt: All prices based on minimum full load of 5000 gallons or 21 tons: unless stated within bid sheet
Diluted material can not be returned for credit; Returns are for material only not freight
Demurrage: \$100.00/hr after 2 free hours.

ERGON ASPHALT & EMULSIONS: This bid is for full transport of 5,500 gallons. Freight is based on a full transport load, even if a full load is not ordered.
Pump and hose charge is \$100.00 per load. Demurrage is billed at \$100 per hour, after the second hour.
Return freight is one-half of the common carrier's outgoing tariff rate.
Federal Environmental Fee will be added to bid prices at a rate of \$0.00150/gal for emulsion loads or \$019770/ton for asphalt & polymer loads.
This fee is not included in the bid price. For equipment ordered but not used (loads not cancelled in a timely manner), the carrier may charge up to a \$400 cancelled load fee which will be paid by the customer.
